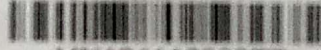

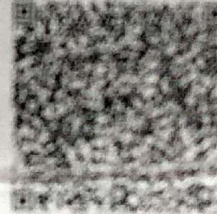

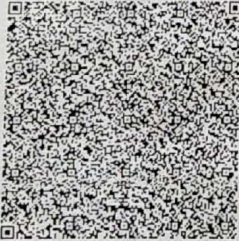

1. The lease shall commence from the Eighteen day of January Two thousand Fourteen and the lease shall be for a period of **(11) Eleven** month and that in case of tenant desires to continue as tenant after the expiry of 11 Eleven month period, then the tenant shall continue for father period as mutually agreed to between the tenant and Landlord, the tenant has to pay an enhanced rent of 5% (Five percent) on the last paid rent, in the same shall be renewable at the option of the parties.

2. The Tenant shall pay a monthly rent of **Rs.8000/- (Rupees Eight thousand only)**, to the Landlord, as monthly rent for the schedule premises and the tenant shall pay the rent punctually on or before **Fifth** day of every English calendar month.

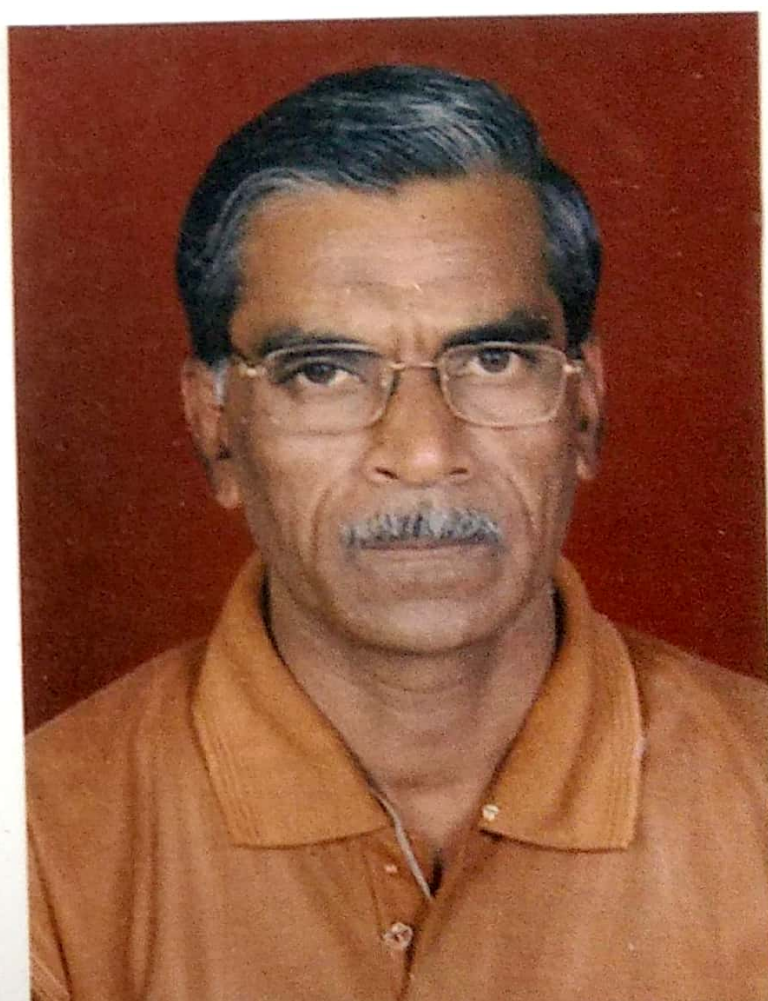
