- In this event of any loss or damage to consignments, which are insured by the Consignor. PPLPL may at the request of the Consignor, issue loss/damage/shortage certificate with the sole purpose of enabling the Consignor to lodge insurance claim with its insurance company. The Consignor. agrees and acknowledges that the loss/shortage/damage_certificate will be issue: VPLPL without admission of any claim and that PPLPL shall be discharged of all liabilities, if any, arising out of the consignment on acceptance of the loss/damage certified by the Consignment.
