The Waybill: The Waybill is non negotiable and the Consignor acknowledges that it has been prepared by the Consignor or by PPL on behalf of the Consignor.

The responsibility of PPL for a consignment accepted under a waybill ceases when the consignee acknowledges the receipt of the consignment by affixing his signature & seal on the return to original copy and or the delivery sheet/mobility device.

All consignments under the waybill are carried at owner's risk.

The Consignor warrants that he is the owner or the authorized agent in the consignment is properly described on this waybill and it does not contravene the provisions of THE NEGOTIABLE INSTRUMENT ACT 1881.

The Consignor warrants that each article in the consignment is properly described on this waybill and for costs incurred either in returning the consignment to the Consignor or warehousing the consignment pending such return.

The Consignor accepts the condition that the consignment is being carried by PPL from point of tendering only up to the address shown on this waybill and in case this consignment has to be returned/rejected/returned for any reason whatsoever, the Consignor shall be in a service all charges levied by PPL for such returned/rejected/return as per the normal schedule of PPL as also any Octroi and state local taxes etc. applicable thereon. PPL will hold such consignment as despatched/mentioned on the waybill for the maximum period of 30 days from the date of consignment.

The Consignor shall reserve the right to destroy the consignment without informing the Consignor and the Consignor shall indemnify PPL against any claim or liability.

INSURANCE: While PPL has developed a tracking system for consignments it does not have an insurance policy and has experienced manpower to handle all consignments. The Consignor may if he so desires insure his consignments at his own cost. PPL will recommend insurance for this purpose at high value consignments. A no point of time PPL liability will not exceed freight amount of the particular consignment.

TAXES: All taxes as Octroi and other statutory payments levied on the consignments are to be borne by the consignee and in his absence the same will be borne by the Consignor. PPL will not extend any credit for Octroi and other statutory charges.

WEIGHT: Every consignment shall be charged by its chargeable weight as defined hereunder and not the actual weight. The chargeable weight shall be higher of (a) the actual weight founded off to the next higher half kg. as per the rate category agreed to or (b) the volume weight (rounded off to 10 kgs) divided by 1375.

LEAVE GOODS SHIPPED: The volume weight of the consignment in kg. its gross cube, cms. (length x width x height) divided by 3375.

PERISHABLE GOODS: Consignments carried under this contract are subject to perishable goods and the Consignor shall be responsible for the goods at all such charges and for or persistent charges in respect of any of all consignments carried under this contract and any failure to surrender possession of the consignment unit will result in such charges as per the normal schedule of PPL.

OTHER: Such charges are not paid to PPL within 10 days, then PPL may store the goods at the debiting Consignor's consignee's own risk.

RIGHT OF RESERVE: The right to sell the goods by public auction, tender, private agreement or otherwise or even destroy the goods without prejudice to PPL other legal remedies to recover its costs, charges and expenses, if the charges as indicated elsewhere remain not paid by the consignee/consignor within 10 days.

PERISHABLE GOODS: PPL does not carry any perishable goods. However, in case of perishable goods, PPL shall have the right to dispose/offload the goods immediately and without any notice and the Consignor shall keep PPL indemnify against all claims, charges and expenses incurred by PPL. Due to such perishable goods entering into the network of PPL.

UNACCEPTABLE: It is deemed to be unacceptable or it has been undervalued for customers/Octroi purposes, or consignee cannot be reasonable identified or located, PPL shall use reasonable efforts to return the consignment to Consignor at its cost, failing which the consignment may be released, disposed of or sold by PPL without incurring any liability whatsoever to the Consignor or anyone else. The proceeds shall be applied against service charges and related administrative costs and the balance of the proceeds shall be returned to Consignor.

LIABILITY AND LIABILITY: The liability of PPL for any loss or damages to the consignment (which item shall include all documents or parcels consigned through PPL) shall be to the extent of the actual value of the document or parcel and the actual value of the document or parcel shall be ascertained by reference to the cost of preparation or replacement/restitution value at the time and place of consignment but under no circumstances shall exceed Rs. 500/-.

CONSIGNMENTS WHICH ARE NOT INSURED: The actual value of the document or parcel shall be ascertained by reference to the cost of preparation or replacement/restitution value at the time and place of consignment but under no circumstances shall exceed Rs. 500/-.

CONSEQUENTIAL DAMAGES EXCLUDED: PPL shall not be liable in any event for any consequential or special damages or other direct or indirect loss, however arising, which PPL has knowledge that such damages might be incurred, including but not limited to loss of income, profit, interest, liability or loss or market.

LIABILITIES NOT ASSUMED: In particular, PPL will not be liable for any loss and damage to the consignment or a delay in picking up or delivering consignment if:

1. Due to acts of god, force majeure occurrence of any cause reasonable beyond the control of PPL or loss or damage caused through strikes, riots, political and other disturbances such as fire, accident of the vehicle carrying the goods, explosions beyond the control of PPL for its goods that are caused by PPL. Caused by

I. The act, fault or omission/ commission of any act of the Consignor/Consignee or any other part claiming an interest in the consignment (including violation of any terms or conditions thereof) or any other person.

II. Carriers such as airlines or airways not adhering to schedule for any reason whatsoever.

III. Government officials in discharge of their official duties such as customs/taxation/Octroi inspection etc.

IV. The nature of the consignment or any defective characteristics of inherent vice therein.

V. Electrical or magnetic injury, fissure or other such damages or photographic images or recording in any form.

VI. Nonwithstanding what is stated above, whilst PPL will endeavor to exercise its best efforts to provide expeditious delivery in accordance with its regular delivery, PPL will not under any circumstances be liable for delay in pick up, transportation or delivery of any consignment in respect of any cause of such delay.

• No liability is assumed for any errors and omissions in any information / date which is imparted in respect of the consignment traveling under the air waybill.

• The Consignor indemnifies PPL against loss, damages, penalties, actions proceeding etc, that may be instituted by any government officials in discharge of their official duties including but not limited to customs/taxation/Octroi inspection etc.

CLAIMS: Any claim must be brought by the CONSIGNOR and delivered, in writing to the office of PPL, nearest to the location at which the consignment is accepted within 30 days from the date of such acceptance. No claim can be made against PPL beyond this time limit.

• No claim for loss or damage will be entertained until charges have been paid. The amount of any such claim will not be deducted from any transportation charges owed to PPL.

• MATTERIALS NOT ACCEPTABLE FOR CARRIAGE: Except as per written agreement between the CONSIGNOR and PPL will not carry materials as under

• Classified as hazardous material, dangerous goods, prohibited, banned or restricted articles by IATA (International Air Transport Association), ICAO (International Civil Aviation Organization), any applicable government department or others relevant organization.

• Not permitted by the laws/regulations/instructions in force or no customs regulations and/or any other relevant laws.

• PPL decides that it cannot transport an item safely or legally. Such items include but are not limited to animals, bullion, currency, negotiable instruments, share certificates and bank shares, precious metals and stones, firearms or parts thereof and ammunition, etc. remains, pornography and illegal narcotics/drugs). Details available in all PPL offices on request.
