The responsibility of PPLPL for a consignment accepted under a waybill ceases when the consignee acknowledges the receipt of the consignment by affixing his signature & seal on the return to original copy and or the delivery sheet/mobility device.

All consignments under the waybill are carried at owner's risk.

CONSIGNORS OBLIGATION AND ACKNOWLEDGMENT: By tendering materials for consignments via PPLPL it is deemed that the Consignors agrees to the terms and conditions stated here.

- The Consignor warrants that he is the owner or the authorized agent of the owner of the goods transported rereunder and that the Consignor here by accepts PPLPL terms and conditions for itself and or as an egent for and on behalf of any other person lawing any interest in the consignment.
- ♦ The Consignor warrants that each articles in the consignment is properly described on this waybill and it dies not contravene the provisions of THE NEGOTIABLE INSTRUMENT ACT 1861
- The Consignor shall be solely liable for all costs and expenses (which shall without limitations include O-tra, state and local taxes and import duties) related to the consignments and for costs incurred either in eturning the consignment to the Consignor or warehousing the consignment pending such return.
