

TERMS & CONDITIONS FOR CARRIAGE

E LOGISTICS PRIVATE LIMITED, (here after this is to be referred as PPLPL) is entitled to perform the transport in any reasonable minner and by any reasonable means, methods and rules. NAYBILL: The PPLPL Waybill is non negotiable and the Consignor acknowledgment that it has prepared by the Consignor or by PPLPL or behalf of the Consignor

he responsibility of PPLPL for a consignment accepted under a waybill ceases when the consignee acknowledges the receipt of the consument by affixing his signature & seal on the return to original copy and or the delivery sneet/mobility device Il consignments under the waybill are carried at owner's risk

SIGNORS OBLIGATION AND ACKNOWLED GMENT: By tendering materials for consignments via PPLPL it is deemed that the Consignor agrees to the terms and conditions stated here.

the Consignor warrants that he is the owner or the authorized agent of the owner of the goods transported hereunder and that the Cérniqua, here by accepts PPLPL terms and conditions for itself and or as an agent for and on behalf of any other person having any interest in the consignment. te Consignor warrants that each articles in the consignment is properly described on this waybill and it does not contravene the provision of THE NEGOTIABLE INSTRUMENT ACT 1881 he Consignor shall be solely liable for all costs and expenses (which shall without limitations include Octroi, state and local taxes and interpretable to the consignments and for costs incurred either in returning the consignment to the Consignor or warehousing the consignment

anding such return. ne Consignor accepts the condition that the consignment is begin carried by PPLPL from point of rendering only upto the address show and this way bill and in case this consignment has to be rerouted /redirected/returned for any reasoft whatsoever, the asignor shall pay in advance all

narges levied by PPLPL for such rerouted /redirected/return as per the normal schedule of PPLPL as also any Octroi and state local taxes sto. applicable thereon. PPLPL will hold such consignment as destination mentioned on the way by for the maximum period of 30 days from the date of onsignment. Thereafter, PPLPL reserves the right to destroy the consignment without informing the Consignor and the Consignor shall in a noity PPLPL against any claim or flability. acking of the material rendered for the consignment is the responsibility of the Consignor.

RANCE: While PPLPL has developed a tracking system for all consignments carried in its network and has experienced manpower to hat rie all consignment. The Consignor may if he so desires insure his consignments at his own cost. PILPL will recommend insurance for this points all high consignment. At no point of time PPLPL liability will not exceed freight amount of the particular consignment.

S: All taxes such as Octroi and other statutory payments levied on the consignments are to be borne by the consignee and in his absence the same will be borne by the Consignor. PPLPL will not extend any credit for Octroi and other statutory charges. REABLE WEIGHT: Every consistent shall be charged by its chargeable weight as defined hereunder and not the actual weight. The disarceable weight shall be higher of (a) the actual weight rounded off to the next higher half kg, as per the rate category agreed to or (b) the volume weight

rly rounded off as in (a) above. Volume weight of the consignment in kg. its gross cube, cms, i.e length x width x height divided by 3375. ON GOODS SHIPPED: The Consignor acknowledges PPLPL's right of lien on its consignments for any outstanding freight any other apply able charges, central, state and local taxes, duties, levies, advances, arising out of transportation and warehousing services, whether pertaining to past

sent outstanding, in respect of any or all consignments carried under this contract and may refuse to surrender possession of the consignment until all such charges are paid. inther, if such charges are not paid to PPLPL within 10 days, then PPLPL may store the goods at the defaulting Consignor's/consignee's out risk.

PLPL further reserves its right to sell the goods by public auction, tender, private agreement or otherwise or even destroy the goods whout prejudice to PPLPL other legal remedies to recover its costs, charges and expenses, if the charges as indicated aforesaid are not paid by the onsignor/consignee within 10 days.

PLPL does not carry any perishable goods. However, in case of perishable goods, PPLPL shall have the right to dispose offisell the goods modified by and without any notice and the Consignor shall keep PPLPL indemnify against all claims, charges and expenses incurred by PPLPL due to ch perishable goods entering into the network of PPLPL

consignee refuses delivery or to pay on delivery, or the consignment is deemed to be unacceptable or it has been undervalued for custome. Si Octroi purposes, or consignee cannot be reasonable identified or located, PPLPL shall use reasonable efforts to return the consignment to Consignment. st. failing which the consignment may be released, disposed of or sold by PPLPL without incurring any liability whatsoever to the Consignment or anyone else. The proceeds shall be applied against service charges and related administrative posts and the before of the proceeds of a sale to be urned to Consignor after adjusting outstanding duties, if any,

ATIONS AND LIABILITY: The liability of PPLPL for any loss or damages to the consignment (which term shall include all documents or bar-sels (ansigned through (PPLPL) shall be lowest or (a)Rs 500/- or (b) the amount of loss or damage to the document or parcel actually sustained for inments which are not insured as mentioned below and the actual value of the document or parcel so determined will be without regard to the commercial utility or special value to the Consignor.

e actual value of the document or parcel shall be ascertained by reference to the cost of preparation or replacement /reconstruction value at the time and place of consignment but under no circumstances shall exceed Rs.500/-

e actual value of a parcel (which term shall include any item of commercial value which is transported here under) shall be ascertain by re-grence to its cost by repair or replacement/resale or lair market value not exceeding the original cost of the article actually paid by the Consignor subject and within overall limit of Rs 500/his event of any loss or damage to consignments, which are insured by the Consignor, PPLPL may at the request of the Consignor, issue oss/framage/shortage certificate with the sole purpose of enabling the Consignor to lodge insurance claim with its insurance company. .ITIES NOT ASSUMED: In particular PPLPL will not be liable for any loss and damage to the consignment or a delay in picking up or delivering consignment if its.

e to acts of god, force majeure occurrence of any cause reasonable beyond the control of PPLPL or loss or damage caused through strikts, nots, political and other disturbances such as fire, accident of the vehicle carrying the goods, explosions beyond the control of PPLPL for the goods tare carried by PPLPL Caused by

act, faul, or omission / commission of any act of the Consignor/Consignee or any other part claiming an interest in the consignment (including violation of any terms or conditions thereof) or any other person

withstanding what is stated above, whilst, PPLPL will endeavor to exercise its best efforts to provide expeditious delivery in accordance with its regular delivery, PPLPL will not under any circumstances be liable for delay in pick up, transportation or delivery of any consignment regardless of se of such delays. iability is assumed for any errors and or omissions in any information / date which is imparted in respect of the consignment traveling under the air waybill.

Consignor indemnities PPLPL against loss, damages, penalties, actions proceeding etc, that may be instituted by any government officials in discharge of their official duties including but not limited to customs/taxation/Octroi inspection et 3: Any claim must be brought by the CONSIGNOR and delivered, in writing to the office of PPLPL nearest to the location at which the consument is accepted within 30 days from the date of such acceptance. No claim can be made against PPLPL beyond this time limit

laim for loss or damage will be entertained until all charges have been paid. The amount of any such claim will not be deducted from any transportation charges owned to PPLPL

IALS NOT ACCEPTALE FOR CARRIAGE: Except as per written agreement between the CONSIGNOR and PPLPL will not carry materials as under isified as hazardous material, dangerous goods, prohibited, banned or restricted articles by IATA (international air Transport Association) ICAO (International Civil Aviation Organization), any applicable government department or others relevant organization.
