TERMS & CONDITIONS FOR CARRIAGE

THE WAYBILL: The PPL Waybill for a consignment is non negotiable and the Consignor acknowledges that it has prepared by the Consignor or by PPL on behalf of the Consignor. The responsibility of PPL for a consignment accepted under a waybill ceases when the consignee acknowledges the receipt of the consignment by affixing his signature & seal on the return copy and/or the delivery sheet/mobility device.

CONSIGNEES OBLIGATIONS AND ACKNOWLEDGEMENT: By tendering materials for consignments via PPL, it is deemed that the Consignor agrees to the terms and conditions stated here. All consignments under the waybill are carried at owner's risk.

- The Consignor warrants that he is the owner or the authorized agent of the owner of the goods transported hereunder and that the consignments here by PPL terms and conditions for itself and as an agent for and on behalf of any other person having any interest in the consignment.
- The Consignor shall be solely liable for all costs and expenses (which shall without limitations include Central, state and local taxes and import duties) related to the consignments and for costs incurred either in returning the consignment to the Consignor or warehousing the consignment pending such return.
- The Consignor shall be solely liable for all costs and expenses (which shall without limitations include Central, state and local taxes and import duties) related to the consignments and for costs incurred either in returning the consignment to the Consignor or warehousing the consignment.
- The Consignor accepts the condition that the consignment is being carried by PPL from point of tendering only upto the address shown on this waybill and in case this consignment has to be returned/repacked/delivered for any reason whatsoever, the Consignor shall pay in advance all charges levied by PPL for such return/repacked/delivered as per the normal schedule of PPL as also any Central and state local taxes etc. applicable thereon. PPL will not extend any credit for Central and other statutory charges.
- The Consignor shall be responsible for the consignment from the point of tendering to the Consignor. The Consignor shall indemnify PPL against any claim or liability.

INSURANCE: While PPL has developed a packing system for all consignments carried in its network and has experienced manpower to handle all consignments. The Consignor may if he so desires insure his consignments at his own cost. PPL will recommend insurance for the points all high value consignment. At no point of time PPL liability will not exceed freight amount of the particular consignment.

TAXES: All taxes such as Central and other statutory payments levied on the consignments are to be borne by the consignee and in his absence the same will be borne by the Consignor. PPL will not extend any credit for Central and other statutory charges.

WEIGHT AND VOLUME: Every consignment shall be charged by its chargeable weight as defined hereunder and not the actual weight. The chargeable weight shall be higher of (a) the actual weight rounded off to the next higher half kg. as per the rate category agreed to or (b) the volume weight (L/1000) rounded off as in (a) above. Volume weight of the consignment in kg. its gross cube cms. (Length x breadth x height) divided by 375.

LINE NO GOODS SHIPPED: The Consignor acknowledges PPL's right of lien on its consignments for any outstanding freight or any other applicable charges, central, state and local taxes, duties, levies, advances, arising out of transportation and warehousing services, whether pertaining to past or present outstanding. In respect of any or all consignments carried under this contract and may refuse to surrender possession of the consignment until all such charges are paid.

• PPL further reserves its right to sell the goods by public auction, tender, private agreement or otherwise or even destroy the goods without prejudice to PPL other legal remedies to recover its costs, charges and expenses, if the charges as indicated aforesaid are not paid by the Consignor/further within 10 days.

• PPL does not carry any perishable goods. However, in case of perishable goods, PPL shall have the right to dispose off/sell the goods immediately and without any notice and the Consignor shall keep PPL indemnify against all claims, charges and expenses incurred by PPL due to the consignment which are not insured and the actual value of the consignment shall be ascertained by reference to the cost of preparation or replacement/reconstruction value at the time and place of consignment but under no circumstances shall exceed Rs 500/-.

• The actual value of the document or parcel shall be ascertained by reference to the cost of preparation or replacement/reconstruction value at the time and place of consignment but under no circumstances shall exceed Rs 500/-.

• The actual value of a parcel (Rs. 500/- and within overall limit of Rs. 500/-) in this event of any loss or damage to the consignment, which are insured by the Consignor, PPL may at the request of the Consignor, issue loss/damage/storage certificate with its sole purpose of enabling the Consignor to lodge insurance claim with its insurance company. The Consignor agrees and acknowledges that the loss/storage/damage certificate will be issued by PPL without admission of any claim and that PPL shall be discharged of all liabilities, if any, arising out of the consignment on acceptance of the loss/damage certificate by the Consignor.

• PPL shall not be liable in any event for any consequential or special damages or other direct or indirect loss, however arising, whether or not PPL has knowledge that such damages might be incurred, including but not limited to loss of income, profit, interest, liability or loss or market.

• PPL will not be liable for any loss and damage to the consignment or delay in picking up or delivering the consignment or damage caused through strikes, riots, political and other disturbances such as fire, accident of the vehicle carrying the goods, explosions beyond the control of PPL for its goods that are carried by PPL. Cause by

1. The act, fault or omission/commission or any act of the Consignor/Consignee or any other part claiming an interest in the consignment (including violation of any terms or conditions thereof) or any other person.

ii. Carriers such as airlines or railways not adhering to schedule for any reason whatsoever.

iii. Government officials in discharge of their official duties such as customs/taxation/Control inspection etc.

iv. Electrical or magnetic injury or other such damages to photographic images or recording in any form.

v. Notwithstanding what is stated above, whilst, PPL will endeavor to exercise its best efforts to provide expeditious delivery in accordance with its regular delivery, PPL will not under any circumstances be liable for delay in pick up, transportation or delivery of any consignment, regardless of cause.

• The Consignor indemnifies PPL against losses, damages, penalties, actions proceedings etc. that may be instituted by any government officials in discharge of their official duties including but not limited to customs/taxation/Control inspection etc.

• Any claim must be brought by the CONSIGNOR, in writing to the office of PPL nearest to the location at which the consignment is accepted within 30 days from the date of such acceptance. No claim can be made against PPL beyond this time limit.

• No claim for loss or damage will be entertained until all charges have been paid. The amount of any such claim will not be deducted from any transportation charges owed to PPL.

• MATRIALS AS HAZARDOUS MATERIAL: Except as per written agreement between the CONSIGNOR and PPL will not carry materials as under.

• Classified as hazardous material, dangerous goods, prohibited, banned or restricted articles by IATA (International Air Transport Association), ICAO (International Civil Aviation Organization), any applicable government or others relevant organization.

• Not permitted by the laws/regulations in force or by regulatory (such items include but are not limited to animals, billion, currency, bearer negotiable instruments, share certificates and blank shares, precious metals and stones, firearms or parts thereof and ammunition, human remains, pornography and illegal narcotics/drugs). Details available in all PPL offices on request.

• PPL decides it cannot transport an item safely or legally (such items include but are not limited to animals, billion, currency, bearer negotiable instruments, share certificates and blank shares, precious metals and stones, firearms or parts thereof and ammunition, human remains, pornography and illegal narcotics/drugs).
