THE WAYBILL: The PPL Waybill is non negotiable and the Consignor acknowledgement that it has prepared by the Consignor or by PPL on behalf of the Consignor.

TERMS & CONDITIONS FOR CONSIGNEES: The PPL is entitled to perform the transport in any reasonable manner and by any reasonable means.

- The responsibility of PPL for a consignment accepted under a waybill ceases when the consignee acknowledges the receipt of the consignment by affixing his signature & seal on the return receipt.
- All consignments under the waybill are carried at owner's risk.
- The Consignor warrants that he is the authorized agent of the owner of the goods transported hereunder and that the Consignor here by accepts PPL terms and conditions for itself and or as an agent for and on behalf of the owner of the goods.
- The Consignor warrants that each article in the consignment is property described on this waybill and it does not contravene the provisions of **THE NEGOTIABLE INSTRUMENT ACT 1881**.
- The Consignor shall be solely liable for all costs and expenses (which shall without limitation include Octroi, state and import duties) related to the consignments and for costs incurred either in returning the consignment or in presenting the consignment for clearance.

The Consignor accepts the condition that the consignment is to be carried by PPL from point of tendering only upto the address shown on this waybill and in case this consignment has to be rerouted/redirectioned/returned for any reason whatsoever, the Consignor shall pay the charges levied by PPL for such redirection/redirection as per the normal schedule of PPL as also any Octroi and state local taxes etc. applicable thereon. VI. Notwithstanding what is stated above, whilst PPL will endeavor to exercise its best efforts to provide expeditious delivery in accordance with its regular delivery, PPL will not under any circumstances be liable for delay in pick up, transportation or delivery of any consignment; regardless of cause of such delay.
