

## TERMS & CONDITIONS FOR CARRIAGE

PON PURE LOCISTICS PRIVATE LIMITED, there after this is to be referred as PPLPL) is entitled to perform the transport in any reasonable means, methods and rules.

THE WAY SILL: The PPLPL Waybill is non negotiable and the Consignor acknowledgment that it has prepared by the Consignor or by PLPL on behalf of the Consignor.

the responsibility of PPLPL for a consignment accepted under a waybill c-ases when the consignee acknowledges the receipt of the agnment by affixing his signature & seal on the return to criginal copy and or the delivery sheet/mobility device.

5 4 consignments under the waybill are carried at owner's risk.

CONSIGNORS OBLIGATION AND ACKNOWLEDGMENT; By tendering materials for consignments via PPLPL it is deemed that the Consignors agrees to the terms and conditions stated here.

- The Consignor warrants that he is the owner or the authorized agent of the owner of the goods transported hereunder and that the Consignor here cepts PPLPL terms and conditions for itself and or as an agent for and on benalf of any other person having any interest in the consignment.
- The Consignor warrants that each articles in the consignment is properly described on this waybill and it does not contravene the prayisions of THE NEGOTIABLE INSTRUMENT ACT 1861.
- The Consignor shall be solely liable for all costs and expenses (which shall without limitations include Octro), state and local taxes and import duties) related to the consignments and for costs incurred either in returning the consignment to the Consignment or warehous ng the consignment pending such return.
- The Consignor accepts the condition that the consignment is begin carried by PPLPL from point of rendering only upto the add east shown on this waybill and in case this consignment has to be rerouted / redirected / returned for any reason whatsoever, the Consignor shall par in advance all charges levied by PPLPL for such rerouted / redirected / return as per the normal schedule of PPLPL as also any Octrai and state local taxes etc. applicable thereon, PPLPL will hold such consignment as destination mentioned on the waybill for the maximum period of 30 days from the date of consignment. Thereafter, PPLPL reserves the right to destroy the consignment without informing the Consignor shall indemnify PPLPL against any claim or liability.
- Packing of the material rendered for the consignment is the responsibility of the Consignor.

INSURANCE: While PPLPL has developed a tracking system for all consignments carried in its network and has experienced manpower to haadle all consignment. The Consignor may if he so desires insure his consignments at his own cost. PPLPL will recommend insurance for this no nts all high value consignment. At no point of time PPLPL liability will not exceed freight amount of the particular consignment.

TAXES: All taxes such as Octroi and other statutory payments levied on the consignments are to be borne by the consignee and in his absence the same will be borne by the Consignor PPLPL will not extend any credit for Octroi and other statutory charges.

C HARGEABLE WEIGHT: Every consignment shall be charged by its charges ble weight as defined hereunder and not the actual weight. The clargeable weight shall be higher of (a) the actual weight rounded off to the next higher half kg, as per the rate category agreed to cr (the the volume weight similarly rounded off as in (a) above. Volume weight of the consignment in sg. its gross cube, cms, i.e length x withn x height divided by 3375.

LIEN ON GOODS SHIPPED: The Consignor acknowledges PPLPL's right of lien on its consignments for any outstanding freight any other applicable charges, central, state and local taxes, duties, levies, advances, arising out of transportation and warehousing service, whether p-retaining to past or present outstanding, in respect of any or all consignments carried under this contract and may refuse to surrender assession o the consignment until all such charges are paid.

- Further, if such charges are not paid to PPLPL within 10 days, then PPLPL may store the goods at the defaulting Consignor's / co
- PPLPL further reserves its right to sell the goods by public auction, tencer, private agreement or otherwise or every destroy the goods without prejudice to PPLPL other legal remedies to recover its costs, charges and experses, if the charges as indicated aforesaic and paid by the Consignor / consignee within 10 days.
- PPLPL does not carry any perishable goods. However, in case of perishable goods, PPLPL shall have the right to dispose off / self the goods. immediately and without any notice and the Consignor shall keen PPLFL indemnify .gainst all claims, charges and expenses neurod by PPLPL due to such perishable goods entering into the network of PPLPL.
- If consignee refuses delivery or to pay on delivery, or the consignment is cecned to be unacceptable or it has been undervalued far customers/ Octro) purposes, or consignee earning the reasonable identified or located, "PLPI, shall use reasonable, efforts to extrust the consignment may be released, cisposed of or sold by Pa\_PL, without induring any liability witasover to the Consignor or anyone else. The proceeds shall be applied against service charges and related administrative costs and the sample of the proceeds of a sale to be returned to Consignor after adjusting outstanding outles, if any

LIMITATIONS AND LIABILITY: The liability of PPLPL for any loss or damages to the consignment (which term shall include all documents or parcels consigned through (PPLPL) shall be lowest of (a) Rs. 500/- or (b) the amount of loss or damage to the document or parcel actually sustained for consignments which are not insured as mentioned below and the



actual value of the document or parcel so determined will be without regard to the commercial utility or special value to the Consignor.

• The actual value of the document or parcel shall be ascertained by reference to the cost of preparation or replacement / reconstruction value at the time and place of consignment but under no circumstances shall exceed Rs. 500/-.

The actual value of a parcel (which term shall include any item of commercial value which is transported here under) shall be ascertain by reference to its cost by repair or replacement / resale or fair market value not exceeding the original cost of the article actually poid by the

Consignor subject to and within overall limit of Rs. 500/-

In this event of any loss or damage to consignments, which are insured by the Consignor, PPLPL may at the request of the Consignor iss.» loss / damage / shortage certificate with the sole purpose of enabling the Consignor to lodge insurance claim with its insurance company. The Consignor agrees and acknowledges that the loss / shortage / damage certificate will be issues by PPLPL without admission of any claim. and that PPLPL shall be discharged of all liabilities, if any, arising out of the consignment on acceptance of the loss/damage certified by the Consigno.

CONSEQUENTIAL DAMAGES EXCLUDED: PPLPL shall not be liable in any event for any consequential or special damages or other direct or indirect loss, however arising, whether or not PPLPL has knowledge that such damages might be incurred, including but not limited to oss of

income, profit, interest, utility or loss or market.

LIABILITIES NOT ASSUMED; In particular PPLPL will not be liable for any loss and damage to the consignment or a delay in picking up or delivering consignment it is.

- i. Due to acts of god, force majeure occurrence of any cause reasonable beyond the control of PPLPL or loss or damage caused trro.sh strikes, nots, political and other disturbances such as fire, accident of the vehicle carrying the goods, explosions beyond the cortro of PPLPL for the goods that are carried by PPLPL Caused by
- ii. The act, fault or omission / commission of any act of the Consignor / Consignee or any other part claiming an interest in the consignment (including violation of any terms or conditions thereof) or any other person.

iii. Carriers such as airlines or airways not adhering to schedule for any reason whatsoever.

iv. Government officials in discharge of their officials in discharge of their official duties such as customs / taxation / Octroi inspect on ex-The nature of the consignment or any defective characteristics of inherent vice therein.

vi. Electrical or magnetic injury erasure or other such damages to photographic images or recording in any form.

 Notwithstanding what is stated above, whilst, PPLPL will endeavor to exercise its best efforts to provide expeditious delivery in accordance with its regular delivery, PPLPL will not under any circumstances be liable for delay in pick up, transportation or delivery of any consignment regardless of cause of such delays.

No liability is assumed for any errors and or omissions in any information / date which is imparted in respect of the consignment traveling under the ai. was fill. The Consignor indemnities PPLPL against loss, damages, penalties, actions proceeding etc, that may be instituted by any government officials in discharge of their official duties including bul not limited to customs / taxation / Octroi inspection etc.

CLAIMS: Any claim must be brought by the CONSIGNOR and delivered, in writing to the office of PPLPL nearest to the location at which the consignment is accepted within 30 days from the date of such acceptance. No claim can be made against PPLPL beyond this time limit

No claim for loss or damage will be entertained until all charges have been paid. The amount of any such claim will not be deducted from any transportation charges owner to PC PL MATERIALS NOT ACCEPTABLE FOR CARRIAGE: Except as per written agreement between the CONSIGNOR and PPLPL will not carry materials as arrier

Classified as hazardous material, dangerous goods, prohibited, banned or restricted articles by IATA (international air Transport Asseciation). ICAO (International Civil Aviation Organization), any applicable government department of others relevant organization.

Not permitted by the laws / rules / restrictions in force or no customs regulations and / or / any other relevant laws.

❖ PPLPI decides it cannot transport an item safely or legally (such items include bur are not limited to animals, bullion, currency, beare negotiable instruments, share certificates and blank shares, precious metals and stones, firearms or parts thereof and ammunition, human remains, pornography and illegal narcotics/drugs).
