TERMS & CONDITIONS FOR CARRIAGE

PON PURE LOGISTICS PRIVATE LIMITED, (here after this is to be referred as PPLPI) is entitled to perform the transport in any rea-onable manner and by any reasonable means, methods and rules.

THE WAYBILL: The PPLPL Waybill is non negotiable and the Consignor acknowledgment that it has prepared by the Consignor or by PPLPL on behalf of the Consignor.

- The responsibility of PPLPL for a consignment accepted under a waybil' cases when the consignee anknowledges the receipt of he consignment by affixing his signature & seal on the return to original copy and or the pelivery sheet/mobility device.
- All consignments under the waybill are carried at owner's risk.

CONSIGNORS OBLIGATION AND ACKNOWLEDGMENT: By tendering materia's for consignments w.a PPLPL it is deemed that the Consignors agrees to the terms and conditions stated here.

- The Consignor warrants that he is the owner or the authorized agent of the owner of the goods transported here index and that the Consignor pere by accepts PPLPL terms and conditions for itself and or as an agent for and on b-half of any other person having any interest in the consignment.
- The Consignor warrants that each articles in the consignment is properly described on his wayb ll and it does not contravene the provisions of THE NEGOTIABLE INSTRUMENT ACT 1861
- The Consignor shall be solely liable for all costs and expenses (which shall without limitation, include Octroi, state and local taxes and import cuties) related to the consignments and for costs incurred either in returning the consignment to the Consignor or warehousing the consignment pending such return.

- If consignee refuses delivery or to pay on delivery, or the consignment is deemed to be unacceptable or it has been undervalue, for rastorners/Octroi purposes, or consignee cannot be reasonable identified or located. PLPL saall use reasonable c forts to return the consignment to Consignor cost, failing which the consignment may be released, disposed of or sold by PPLPL without incurring any liability whatsoever to the Consignor or anyone else.
