TERMS & CONDITIONS FOR CARRIAGE

POW PURE LOGISTICS PRIVATE LIMITED, (here after this is to be referred as PPL2), is entitled to perform the transport in any reasonable manner and by any reasonable means, methods and rules.

THE WAYBILL: The PPL Waybill is non negotiable and the Consignor acknowledges that it is prepared by the Consignor or by PPL2. On behalf of the Consignor.

The responsibility of PPL2 for a consignment accepted under a waybill ceases when the consignee acknowledges the receipt of the consignment by affixing his signature & seal on the return to original copy and on the delivery sheet/trailability device.

All consignments under the waybill are carried at owner's risk.

CONSIGNMENT OBLIGATION AND ACKNOWLEDGMENT: By tendering materials for consignments to PPL2 it is deemed that the Consignor agrees to the terms and conditions stated here.

The Consignor warrants that he is the owner or the authorized agent of the owner of the goods transported hereunder and that the Carrier here by accepts PPL2 terms and conditions for itself and on behalf of any other persons having any interest in the consignment.

The Consignor warrants that each article in the consignment is properly described on this waybill and it does not contravene the provisions of THE NEGOTIABLE INSTRUMENTS ACT 1881.

The Consignor shall be solely liable for all costs and expenses (which shall without limitations include Octroi, state and local taxes and import duties) related to the consignments and for costs incurred either in relating the consignment to the Consignor or watching the consignment pending such return.

The Consignor accepts the condition that the consignment is being carried by PPL2 from point of tendering only upto the address shown on this waybill and in case this consignment has to be returned / redelivered / returned for any reason whatsoever, the Consignor shall pay in advance all charges levied by PPL2 for such return / redeliver / return as per the terms and conditions of PPL2 as a so on the manner and date of local taxes etc. applicable thereon. PPL2 will hold such consignment as per the instructions mentioned on the waybill for the duration of period of 30 days from the date of consignment. Thereafter, PPL2 reserves the right to destroy the consignment without informing the Consignor and the Consignor shall indemnify PPL2 against any claim or liability.

Packing of the material tendered for the consignment is the responsibility of the Consignor.

INSURANCE: While PPL2 has developed a tracking system for all consignments carried in its network and has exercised maximum to make all consignments. The Consignor may if he so desires insure his consignments at his own cost. PPL2 will recommend insurance for this purpose at its high value consignment. At no point of time PPL2 liability will not exceed freight amount of the particular consignment.

TAXES: All taxes such as Octroi and other statutory levies levied on the consignments are to be borne by the consignor and in the absence of the same will be borne by the Consignor. PPL2 will not extend any credit for Octroi and other statutory charges.

CHANGABLE WEIGHT: Every consignment shall be changed by its changeable weight as declared hereon for and not the actual weight. The changeable weight shall be higher of (a) the actual weight rounded off to the next higher half kg. as per the rate category agreed to or (b) the volume weight similarly rounded off as in (a) above. Volume weight of the consignment in kg. its gross cube, cms, i.e length x width x height divided by 375.

LITEN ON GOODS SHIPPED: The Consignor acknowledges PPL2's right of lien on his consignments for any outstanding freight and other applicable charges, present or future, duties, levies, advances, carried out of its consignment and any refusal to surrender possession pertaining to past or present outstanding. In respect of all consignments carried under this contract and any refusal to surrender possession of the consignment until all such charges are paid.

Further, if such charges are not paid to PPL2 within 10 days, then PPL2 may store the goods at the defaulting Consignor's / consignee's warehouse. PPL2 further reserves its right to sell the goods by public auction, tender private agreement or otherwise or even destroy the goods without prejudice to PPL2's other legal remedies to recover its costs, charges and expenses. If the charges as indicated hereon is not paid by the Consignor / consignee within 10 days.

PPL2 does not carry any perishable goods. However, in case of perishable goods, PPL2 shall have the right to dispose of / sell the goods immediately and without any notice and the Consignor shall keep PPL2 indemnify against all claims, charges and expenses incurred by PPL2 due to such perishable goods entering into the network of PPL2.

If consignees refuses delivery or to pay on delivery or the consignment is deemed to be unacceptable or it has been unperfected for whatsoever reasons or for any other cause, the Consignor shall be applied against service charges and related administrative costs and the balance of the proceeds of a sale to be returned to Consignor after adjusting outstanding duties, if any.

LIABILITIES AND LIABILITY

The liability of PPL2 for any loss or damages to the consignment (which items shall include all documents or parcels consigned through PPL2) shall be forwarded to the document or parcel actually damaged to (a) Rs. 500/- or (b) the amount of loss or insured as mentioned below and the insured as mentioned below and the actual value of the document or parcel so determined will be without regard to the commercial utility of special value to the Consignor.

The actual value of the document or parcel shall be ascertained by reference to the cost of preparation or replacement / reconstruction where at the time and place of consignment but under no circumstances shall exceed Rs. 500/-.

The actual value of a parcel (which item shall include any form of commercial value which is transported here under) shall be ascertained by reference to its cost by repair or replacement or its market value not exceeding the original cost of the article actually paid by the Consignor.

In case of any loss or damage to consignments, which are insured by the Consignor, PPL2 may at the request of the Consignor, issue loss, damage / shortage certificate with the sole purpose of enabling the Consignor to lodge insurance claim with its insurance company. The Consignor agrees and acknowledges that the sole purpose of enabling the Consignor to lodge insurance claim with its insurance company. The PPL2 shall be discharged of all liabilities if any arising out of the consignment on acceptance of the loss/damage certified by the Consignor. PPL2 shall not be liable in any event for any consequential or special damages or other direct or indirect loss, however arising, whether or not PPL2 has knowledge that such damages might be incurred, including but not limited to loss of or damage to, interest, utility or loss of material.

LIABILITIES NOT ASSUMED: PPL2 will not be liable for any loss and damage to the consignment or a delay in packing up delivering consignment if it, due to acts of god, force majeure occurrence or any cause reasonable beyond the control of PPL2 or loss or damage caused through strikes, riots, political and other disturbances such as fire, accident of the vehicle carrying the goods, explosions beyond the control of PPL2 for the goods that are carried by PPL2, caused by.

ii. The act, fault or omission / commission or any act of the Consignor / Consignee or any other part claiming an interest in the consignment (including violation of any terms or conditions thereof) or any other person.

iii. Carriers such as airlines or airways not adhering to schedule for their official duties such as customs / taxation / Octroi inspection etc.

iv. Consignment officials in discharge of their official duties in discharge of their official duties such as customs / taxation / Octroi inspection etc.

v. The nature of the consignment or any defective characteristics of inherent vice therein.

vi. Electrical or magnetic injury causes or other such damages to products during measures or recording in any form.

Notwithstanding what is stated above, whilst PPL2 will endeavor to exercise its best efforts to provide expedient deliveries in accordance with its regular delivery, PPL2 will not under any circumstances be liable for delay in pick up, transportation or delivery of any consignment regardless of cause of such delays.

No liability is assumed for any errors and or omissions in any information, data which is imparted in respect of the consignment traveling under the air waybill. The Consignor indemnifies PPL2 against loss, damages, penalties, actions proceeding etc. that may be instituted by any government officials in discharge of their official duties but not limited to customs / taxation / Octroi inspection etc.

CLAIMS: Any claim must be brought by the Consignor and delivered, in writing to the office of PPL2 nearest to the location at which the consignment is accepted within 30 days from the date of such acceptance. No claim can be made against PPL2 beyond this time limit.

No claim for loss or damage will be entertained until all charges have been paid. The amount of any such claim will not be deducted from any transportation charges owed to PPL2.

MATERIALS NOT ACCEPTABLE FOR CARRIAGE: Except as per written agreement between the Consignor and PPL2 will not carry materials as under classified as hazardous material, dangerous goods, prohibited, banned or restricted articles by IATA (International Air Transport Association), ICAO (International Civil Aviation Organization), any applicable government department or others relevant organization.

Not permitted by the laws / rules / restrictions in force or no customs regulations and / or any other relevant laws.

PPL2 declares it cannot transport an item safely or legally (such items include but are not limited to animals, bullion, currency, bearer negotiable instruments, share certificates and bank shares, precious metals and stones, firearms or parts thereof and ammunition, human remains, pornography and illegal narcotics/drugs).
