

## TERMS & CONDITIONS FOR CARRIAGE

**THE WAYBILL:** The Waybill is non negotiable and the Consignor acknowledgment that it has prepared by or by PPL

on behalf of the Consignor.

The responsibility of PPL for a consignment accepted under a waybill ceases when the consignee acknowledges the receipt of the consignment by affixing his signature & seal on the return to original copy and or the delivery sheet/acknowledgement.

All consignments under the waybill are carried at owner's risk.

**CONSIGNOR'S OBLIGATION AND ACKNOWLEDGMENT:** By tendering materials for consignments via PPL it is deemed that the Consignor agrees to the terms and conditions stated here.

The Consignor warrants that he is the owner or the authorized agent of the goods transported hereunder and that the Consignor here by accepts PPL terms and conditions for and on behalf of any other person having any interest in the consignment.

The Consignor warrants that each article in the consignment is properly described on this waybill and it does not contravene the provisions of the NEGOTIABLE INSTRUMENT ACT 1861.

The Consignor shall be solely liable for all costs and expenses (which shall include without limitations include Octroi, state and local taxes and import duties) related to the consignments and for costs incurred either in returning the consignment to the Consignor or warehousing the consignment pending such return.

**TAXES:** All taxes such as Octroi and other statutory payments levied on the consignments are to be borne by the consignor and in his absence the same will be borne by the Consignor. PPL will not be charged any credit for Octroi and other statutory charges.

**CHANGEBLE WEIGHT:** Every consignment shall be charged by its changeable weight as defined hereunder and not the actual weight. The changeable weight shall be higher of (a) the actual weight rounded off to the next higher half kg as per the rate category agreed to or (b) the volume weight similarly rounded off as in (a) above. Volume weight of the consignment in kg, its gross cube x cms, its length x width x height divided by 337.

**LIEN ON GOODS SHIPPED:** The Consignor's right of lien on his consignments for any outstanding freight any other applicable charges, central, state and local taxes, duties, levies, advances, arising out of transportation and warehousing services, whether performed in past or present outstanding, in respect of any or all consignments carried under this contract and may refuse to surrender possession of the consignment until all such charges are paid.

Further, if such charges are not paid to PPL within 10 days, then PPL may store the goods at the defaulting Consignor's / consignee's own risk, without prejudice to PPL's other legal remedies to recover its costs, charges and expenses, if the charges as indicated aforesaid are not paid by the Consignor / consignee within 10 days.

PPL does not carry any perishable goods. However, in case of perishable goods, PPL shall have the right to dispose off / sell the goods immediately and without any notice and the Consignor shall keep PPL indemnity against all claims, charges and expenses incurred by PPL in such perishable goods entering into the network of PPL.

If consignor refuses delivery or to pay on delivery, or the consignment is deemed to be unacceptable or it has been unperfected for customers / Octroi purposes, or consignee cannot be reasonably located, PPL shall use reasonable efforts to return the consignment to the Consignor at Consignor cost, failing which the consignment may be released, disposed of or sold by PPL without incurring any liability whatsoever to the Consignor or anyone else. The proceeds shall be applied against service charges and related administrative costs and the balance of the

proceeds of a sale to be returned to Consignor after adjusting and deducting therefrom the amount of PPL's liability of PPL for

as damages on the consignment (which term shall include all documents or parcels consigned through PPL) shall be lowest of (a) Rs. 500/- or (b) the amount of loss or damage to the document or parcel as determined by the Consignor.

The actual value of the document or parcel shall be ascertained by reference to the cost of preparation or replacement / reconstruction value at the time and place of consignment but under no circumstances shall exceed Rs. 500/-.

The actual value of a parcel (which term shall include any item of commercial value which is transported here under) shall be ascertained by reference to its cost by repair or replacement / resale or fair market value not exceeding the original cost of the article actually paid by the Consignor subject to and within overall limit of Rs. 500/-.

In this event of any loss or damage to consignments, which are insured by the Consignor, PPL may at the request of the Consignor, issue Consignor agrees and acknowledge that the loss / shortage / damage certificate will be issued by PPL without admission of any claim or that PPL shall be discharged of all liabilities, if any, arising out of the consignment on acceptance of the loss/damage certified by the Consignor and that PPL shall not be liable in any event for any consequential or special damages or other direct or indirect loss, however arising, whether or not PPL has knowledge that such damages might be incurred, including but not limited to loss of income, profit, interest, utility or loss of market.

**LIABILITIES NOT ASSUMED:** In particular PPL will not be liable for any loss and damage to the consignment or a delay in picking up or delivering consignment if its Due to acts of god, force majeure occurrence of any cause reasonable beyond the control of the Consignor, explosion or loss or damage caused through strikes, riots, political and other disturbances such as fire, accident, or loss of the vehicle carrying the goods, explosions beyond the control of PPL for the goods that are carried by PPL. iii. Carriers such as airlines or railways not adhering to schedule for any reason whatsoever.

iv. Consignment officials in discharge of their official duties such as customs / taxation / Octroi inspection etc.

v. The nature of the consignment or any defective characteristics of inherent vice therein.

vi. Electrical or mechanical injury retrace or other such damages or photographic images or recording in any form.

vii. Notwithstanding what is stated above, while PPL will endeavor to exercise its best efforts to provide expeditious delivery in accordance with its regular delivery, PPL will not incur any circumstances be liable for delay in pick up, transportation or delivery of any consignment regardless of cases of such delays.

viii. No liability is assumed for any errors and or omissions in any information / date which is imparted in respect of the consignment traveling under the air waybill. The Consignor indemnifies PPL against loss, damages, penalties, actions, accretions / taxation / Octroi inspection etc.

ix. Consignor officials in discharge of their official duties including but not limited to customs / taxation / Octroi inspection etc.

x. Any claim must be made against PPL and delivered in writing to the office of PPL nearest to the location at which the consignment is accepted within 30 days from the date of such acceptance. No claim can be made against PPL beyond this time limit.

xi. No claim for loss or damage will be entertained until all charges have been paid. The amount of any such claim will not be deducted from any transportation charges owed to PPL. MATRIALS NOT ACCEPTABLE FOR CARRIAGE: Consignor as per written agreement between the Consignor and PPL will not carry materials as under

(Classified as hazardous material, dangerous goods, prohibited, banned or restricted articles by IATA (International Air Transport Association), ICAO (International Civil Aviation Organization), any applicable government department or others relevant organization.

Not permitted by the laws / rules / restrictions in force or on customs regulations and / or / any other relevant laws.

PPL decides it cannot transport an item safely or legally (such items include but are not limited to animals, bullion, currency, bearer negotiable instruments, share certificates and blank shares, precious metals and stones, firearms or parts thereof and ammunition, human remains, pornography and illegal narcotics/drugs).
