



In the event of any breach of this contract by the Company, the remedies of the Customer shall be limited to damages. Under no circumstances shall the liability of the Company exceed the Price of the Goods. The Company has the right to change, amend, alter or revise the above General Terms and Conditions from time to time without prior notification.

VII. JURISDICTION

All the disputes are subject to the jurisdiction of Thane Courts only.
