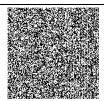

In addition to any right of lien to which the Company shall be entitled to a general lien on all Goods of the Customer in their possession (although such Goods or some of them may have been paid for) for the unpaid price of any other Goods sold and delivered by the Company to the Customer and for any other moneys owning by the Customer to the Company upon this or any other contract.

# **V.WARRANTIES AND LIABILITY**

The Company warrants that the Goods will at the time of delivery correspond to the description given by the Company.

#### **VI.GENERAL**

No waiver by the Company of any breach of the contract by the Customer shall be considered as waiver of any subsequent breach of the same or any other provision. The specification(s) and design(s) of the Goods (including the copyright, design right or other intellectual property in them) shall as between the parties be the property of the Company.

These Conditions shall apply to all contracts for the sale of Goods by the Company to the Customer to the exclusion of all other terms and conditions including any terms or conditions which the Customer may purport to apply under any purchase order confirmation of order or similar document.

The Company shall be under no liability whatever to the Customer for any indirect loss and/ or expense (including loss of profit) suffered by the Customer arising out of a breach by Company of this contract. In the event of any breach of this contract by the Company, the remedies of the Customer shall be limited to damages. Under no circumstances shall the liability of the Company exceed the Price of the Goods. The Company has the right to change, amend, alter or revise the above General Terms and Conditions from time to time without prior notification.

# **VII. JURISDICTION**

All the disputes are subject to the jurisdiction of Thane Courts only.
