DEFINITIONS

"Company": Means Panasonic Life Solutions India Private Limited (formerly known as Anchor Electricals Private Limited)

"Customer": Means the Customer whose name is mentioned herein on the face of this document.

"Conditions": Means the terms and conditions of sale set out in this document and any special terms and conditions agreed in writing by the company.

"Goods": Means the articles which the Customer agrees to buy from the Company.

"Price": Means the price of Goods.

"Order" : Means any request for Goods issued by Customer or User of Goods

I.THE PRICE AND PAYMENT

1. Payment of the Price shall be due, without any deduction, as specified on the surface of this paper. Time for payment shall be the essence. All other terms and conditions relating to the payment shall be as specified herein under:-

If the Customer fails to make any payment on the due date then, the Company shall be entitled to:
